## **History and overview of the Open World, Rule of Law Program in Las Vegas**

In Las Vegas, Judge Lloyd D. George, Senior United States District Judge for the District of Nevada has hosted delegates from Eurasia as part of the Open World, Rule of Law program since the inception of the program in 1999. Shortly thereafter, a partnership was formed with the Fremont Rotary Club to act as the "Host Rotary Club", participating and assisting in the coordination of activities before and during the exchange as well as administering the grant for the program. In 2008, the committee was further expanded to include "Rotary Clubs of Southern Nevada" with the grant administered by the Las Vegas Rotary Club. Today there are eighteen Rotary Clubs throughout Southern Nevada with approximately one hundred members from various clubs participating in the Open World, Rule of Law program along with Judge George, the "Host Judge" and his incredible committee of members from the legal and professional community. It is a perfect partnership. Each committee member and participant is invaluable to the success of the program.

The Las Vegas Rotary Club is the oldest and largest club in Las Vegas, chartered in 1923, at a time when Las Vegas was a sleepy railroad town. There was no glamour along the streets as you see today. There were no paved roads from here to anywhere. Dirt roads, rut filled and dusty, moved out of Las Vegas in two directions, North and South. The history of the Las Vegas Rotary Club is deeply imbedded into the history and growth of the City of Las Vegas and its community.

The Las Vegas Rotary Club has recorded many "firsts" but one of the most memorable occurred in 1927. The President of the new phone company and member of the Las Vegas Rotary Club, made the "first" long distance phone call in Nevada at a Rotary meeting to the Mayor in Reno. Up to that point, the only service from Las Vegas was via Union Pacific telegraph. Another notable event was the inaugural ceremonies officiated by the Las Vegas Rotary Club for the opening of Hoover Dam.

The Las Vegas Rotary Club as with all Rotary Clubs in Nevada and throughout the world, are service clubs of professional business people who strive to make their local and international community a better place. The Rotary "Wheel" can be seen throughout Las Vegas, at parks, schools, on benches, the airport Aviation display, reforestation projects, highway clean ups, libraries, medical and child help facilities and endless other projects performed by Rotarians. The spirit of Rotary can be felt in the hearts and souls of many who have seen the generosity of Rotarians through hands on projects, feeding the hungry, caring for the less fortunate, support programs for our military, student sports activities, professional exchanges, grants and scholarships. Rotary's motto "Service Above Self" is a way of life for Rotarians in the Las Vegas community.

Our goal is to have the best Open World, Rule of Law program in the country. We believe with our incredible team and amazing program, we have accomplished that goal. Rotarians are honored to work with Judge George and his committee, promoting peace and good will through the "rule of law". We welcome our international guests each year. After the delegates have completed the program, we all have a better understanding of one another. As Rotarians we truly believe we have a lot more similarities than we have differences.
